Notes on Ectodermal Dysplasia Society Trustee Nomination Form 2023

Background

- 1 With the adoption of a Constitution on 14 July 2001, the arrangements for the election of Ectodermal Dysplasia Society trustees are as follows :-
 - a) The Executive Committee will now consist of a minimum of ten elected Trustees. Three of the elected trustees shall be elected to the posts of Chair, Secretary and Treasurer. The rest will be Ordinary Trustees.
 - b) Every trustee may serve for up to three years before they must retire and seek re-election if they wish to continue.

Nomination Process

- 2 All Nominees (i.e. those putting themselves forward for election as an Ectodermal Dysplasia Society Trustee) must be an Associate or Full member.
- 3 All those proposing a member for election as a trustee must themselves be member or Trustee. All nomination forms must be signed by the Proposer.
- 4 All nomination forms must be signed by the Nominee to show his or her willingness to be appointed.
- 5 Remember to complete all the boxes and provide a supporting statement.
- 6 Don't forget to tick one of the four boxes indicating whether you are standing for one of the three named posts or as an Ordinary Trustee.
- 7 Send the completed form to the Ectodermal Dysplasia Society, Unit 1 Maida Vale Business Centre, Cheltenham GL53 7ER (copies sent by email to info@edsociety.co.uk will be accepted).
- 8 The closing date for receipt of completed forms is Thursday 13th April 2023.

- 9 If nominations exceed the number of places available there will be a ballot.
- 10 The results of the 2023 election of trustees will be announced during the 2023 AGM which will be held at 10.00 on Saturday 22nd April 2023.
